# DESCRIPTION

The Solactive United Kingdom Broad Market Small Cap EUR Index PR intends to track the performance of the companies from the Solactive United Kingdom Broad Market Index that are not part of the Solactive United Kingdom 350 Index. Constituents are selected based on full security market capitalization and weighted by free-float market capitalization. The index is calculated as a price return index in EUR and reconstituted quarterly.




