Constituents are selected based on company market capitalization and weighted by free float market capitalization. The index is calculated as a net total return index in USD and reconstituted quarterly.

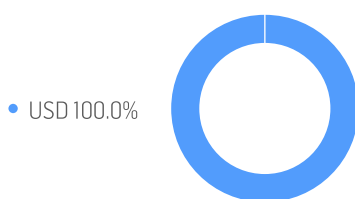

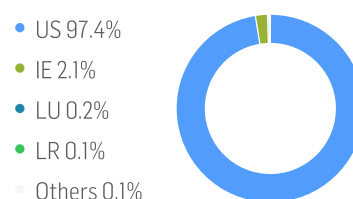
