


FACTSHEET - AS OF 06-Jun-2025 Solactive United States 800 Index

DESCRIPTION

The Solactive United States 800 Index intends to track the performance of the largest 201 to 1000 companies from the United States stock market. Constituents are selected based on company market capitalization and weighted by free float market capitalization. The index is calculated as a price return index in USD and reconstituted quarterly.


