

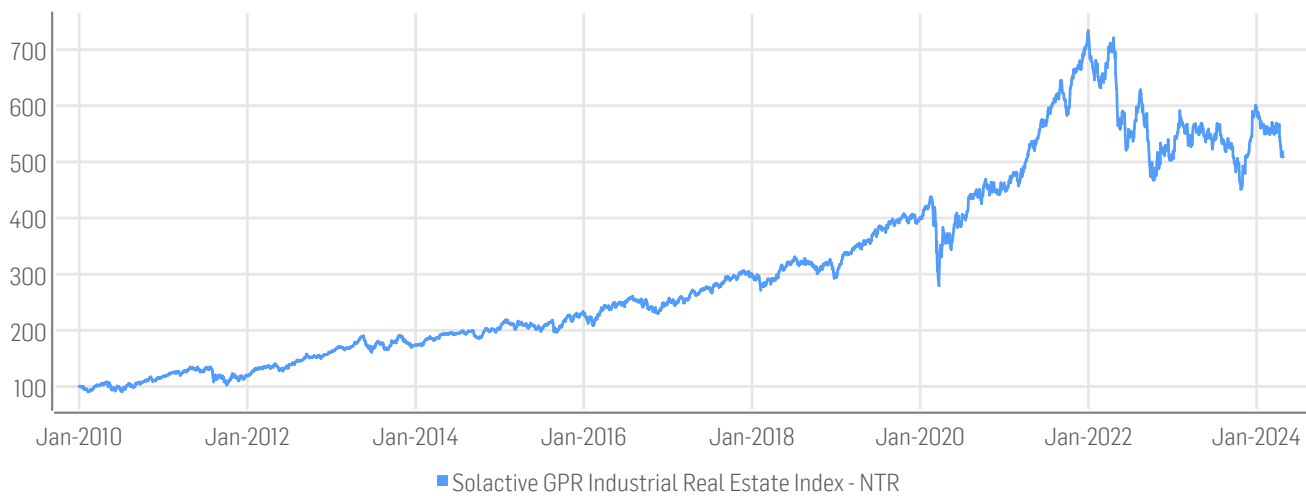

DESCRIPTION

The Solactive GPR United States REIT ex Timber and Mortgage Index NTR is based on the Solactive GBS United States Investable Universe Index. All index components must be classified as Real Estate Investment Trust, but Timber REITs and Mortgage REITs are excluded. The index is weighted by free float market capitalization, calculated as a net total return index in USD and reconstituted quarterly.

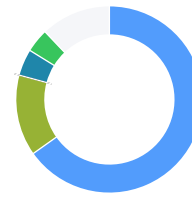
COMPOSITION BY CURRENCIES
