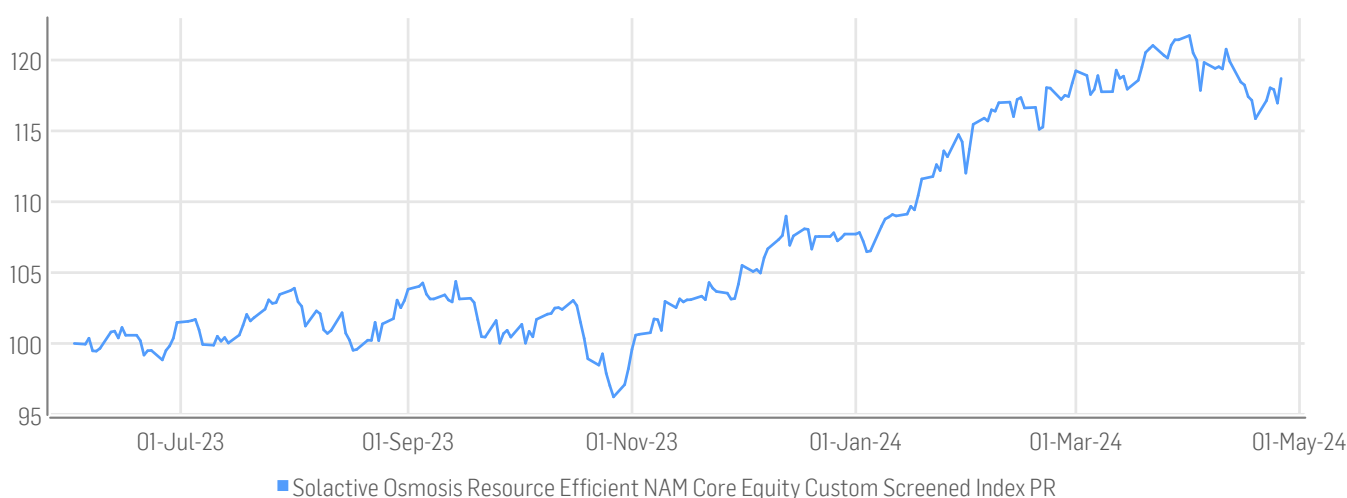


Solactive Osmosis Resource Efficient NAM Core Equity Custom Screened Index PR

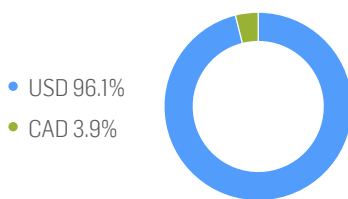

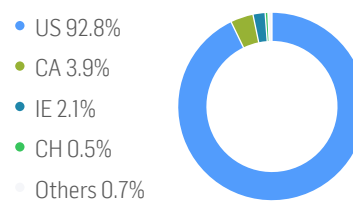
