

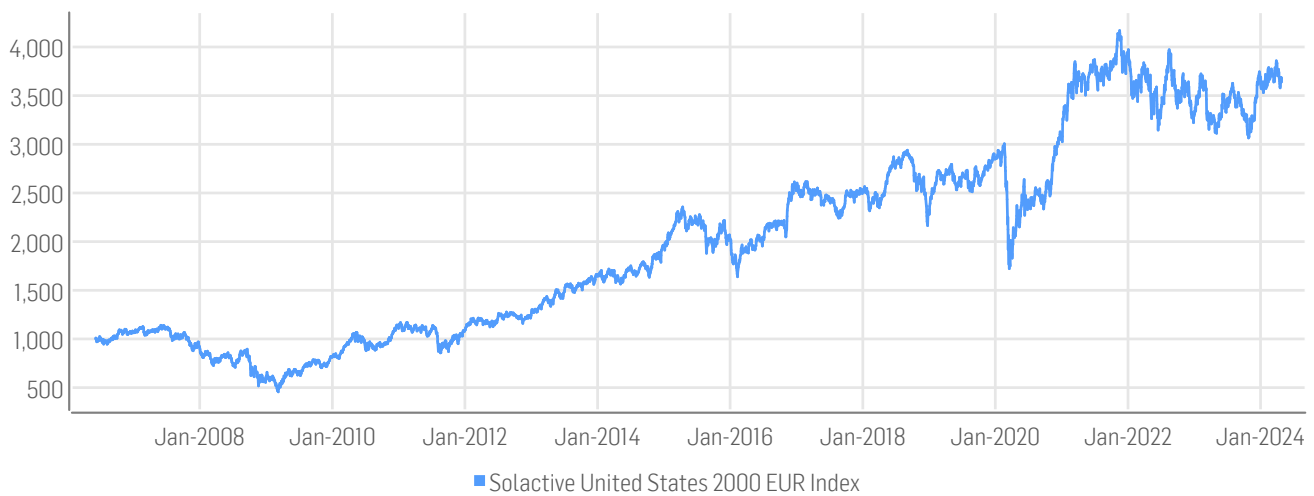

DESCRIPTION

The Solactive United States 2000 EUR Index intends to track the performance of the largest 1001 to 3000 companies from the United States stock market. Constituents are selected based on company market capitalization and weighted by free float market capitalization. The index is calculated as a price return index in EUR and reconstituted quarterly.

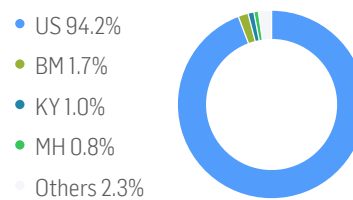
