Constituents are weighted by free-float market capitalization and capped at 3.5%.

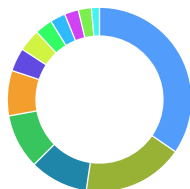

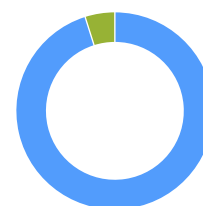
