### DESCRIPTION

The Solactive Eurozone 60 Ex Financials 5 % Capped Index NTR intends to track the performance of the 60 largest companies from the Eurozone stock market excluding the financial sector. Constituents are selected based on the company market capitalization and weighted by free-float market capitalization subject to a 5% security capping. The index is calculated as a net total return index in EUR.

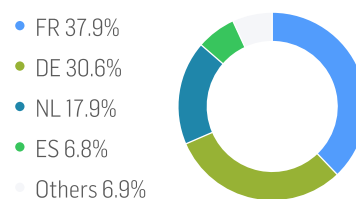
