## DESCRIPTION

The Solactive GBS Global Markets ex China Investable Universe EUR Index PR is part of the Solactive Global Benchmark Series which includes benchmark indices for developed and emerging market countries. The index intends to track the performance of the investable universe segment covering approximately the largest 99% of the free-float market capitalization in the Global Markets ex China. It is calculated as a price return index in EUR and weighted by free-float market capitalization.

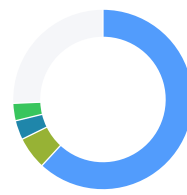
