

DESCRIPTION

The Solactive United States Technology 100 Capped C1 GBP Index TR intends to track the performance of the largest 100 companies from the NASDAQ Stock Exchange. Constituents are selected based on full security market capitalization and weighted by free-float market capitalization subject to the weight constraints: "4.5/14/38.5". The index is a total return index in GBP and reconstituted quarterly.
