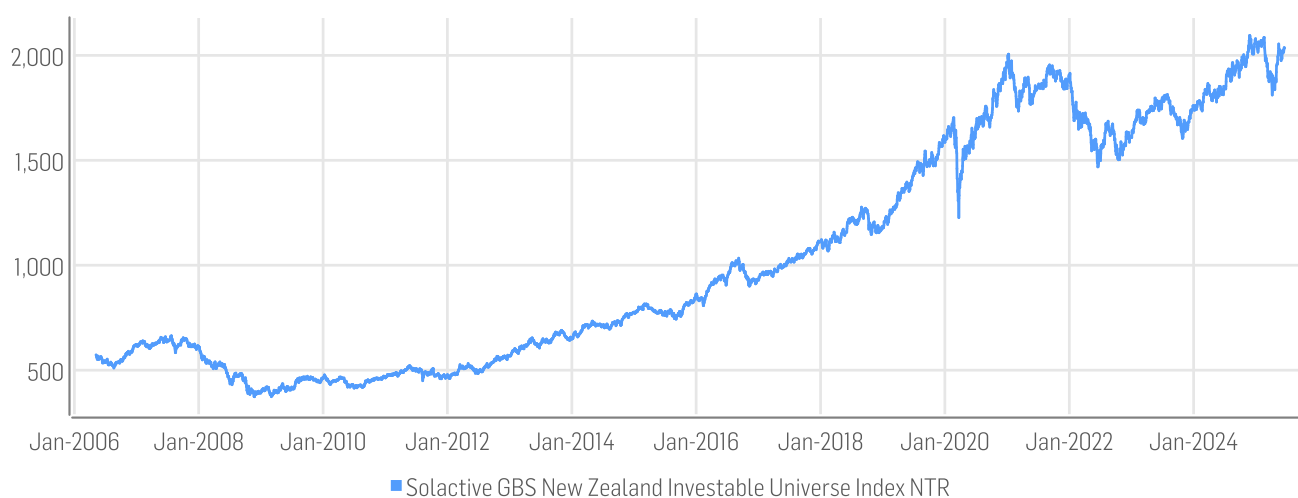

### DESCRIPTION

It is calculated as a net total return index in NZD and weighted by free-float market capitalization.

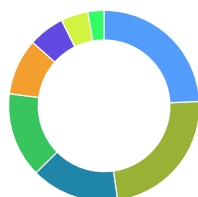

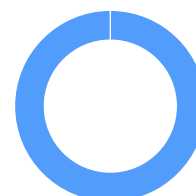
