Constituents are selected based on company market capitalization and weighted by free float market capitalization. The index is calculated as a price return index in EUR and reconstituted quarterly.

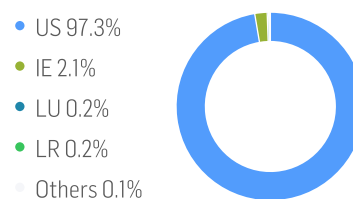
