


FACTSHEET - AS OF 06-Jun-2025 Solactive United States 2500 GBP Index TR

DESCRIPTION

The Solactive United States 2500 Index GBP TR intends to track the performance of the largest 501 to 3000 companies from the United States stock market. Constituents are selected based on company market capitalization and weighted by free float market capitalization. The index is calculated as a total return index in GBP and reconstituted quarterly.


