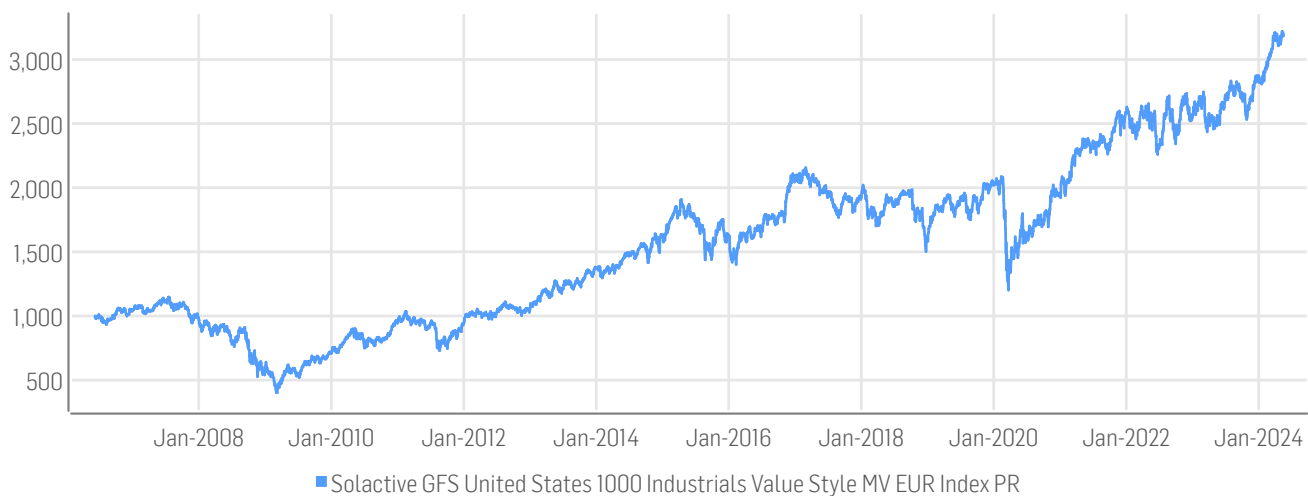


Solactive GFS United States 1000 Industrials Value Style MV EUR Index PR

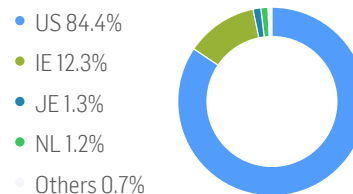
