DESCRIPTION

The Solactive GBS Emerging Markets EMEA Investable Universe USD Index TR is part of the Solactive Global Benchmark Series which includes benchmark indices for developed and emerging market countries. The index intends to track the performance of the investable universe covering approximately the largest 99% of the free-float market capitalization in the Emerging Markets EMEA. It is calculated as a total return index in USD and weighted by free-float market capitalization.

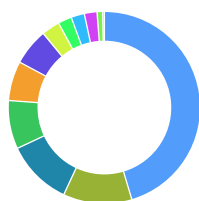
