


FACTSHEET - AS OF 20-May-2025 Solactive Australia 300 ex 100 EUR Index TR

DESCRIPTION

The Solactive Australia 300 ex 100 EUR Index TR intends to track the performance of the largest 101 to 300 companies from the Australian Securities Exchange. Constituents are selected and weighted based on free-float market capitalization. The index is calculated as a total return index in EUR and reconstituted quarterly.


