The Solactive Australia 50 ex 20 USD Index NTR intends to track the performance of the largest 21 to 50 companies from the Australian Securities Exchange. Constituents are selected and weighted based on free-float market capitalization. The index is calculated as a net total return index in USD and reconstituted quarterly.

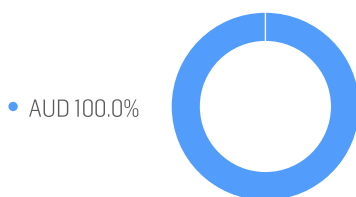

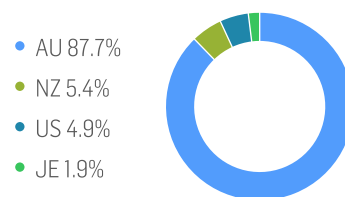
