

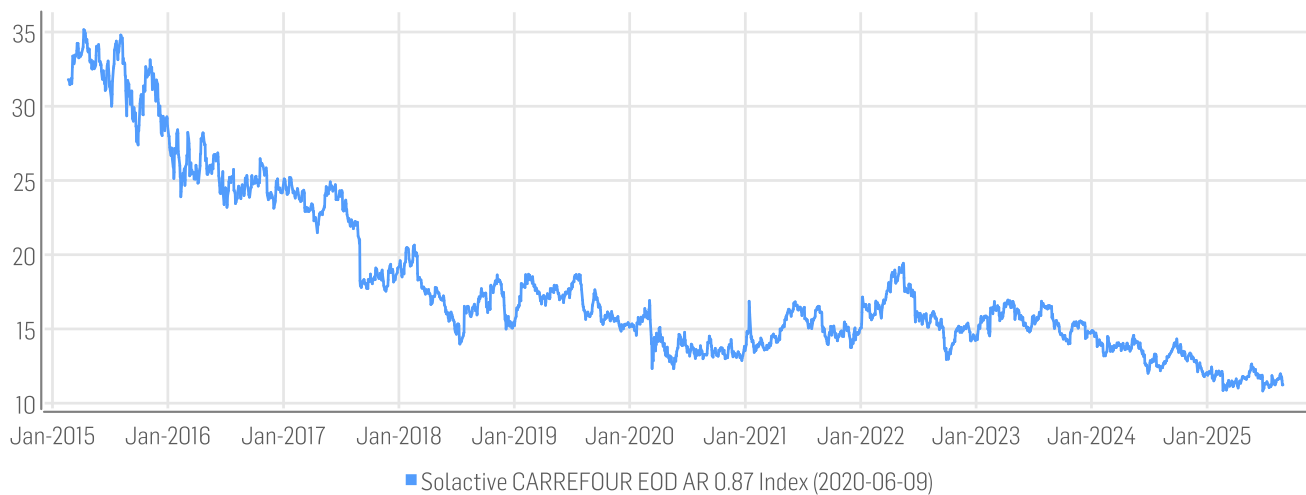

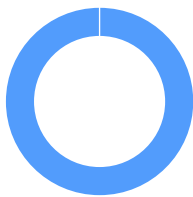

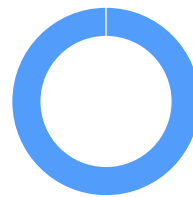
COMPOSITION BY CURRENCIES
