DESCRIPTION

The Solactive Eurozone Diversified Sector Top 30 Index NTR intends to track the performance of the largest 30 securities from diverse sectors within the Eurozone market. It is calculated as a net total return index in EUR and reconstituted quarterly. Constituents are weighted based on free float market capitalization subject to a 10% capping.

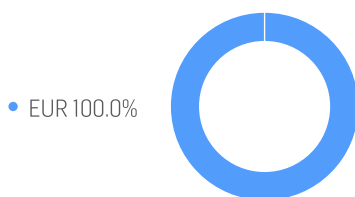

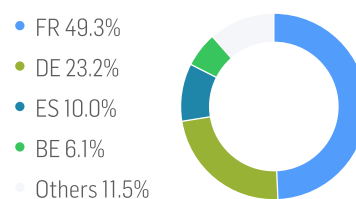
