

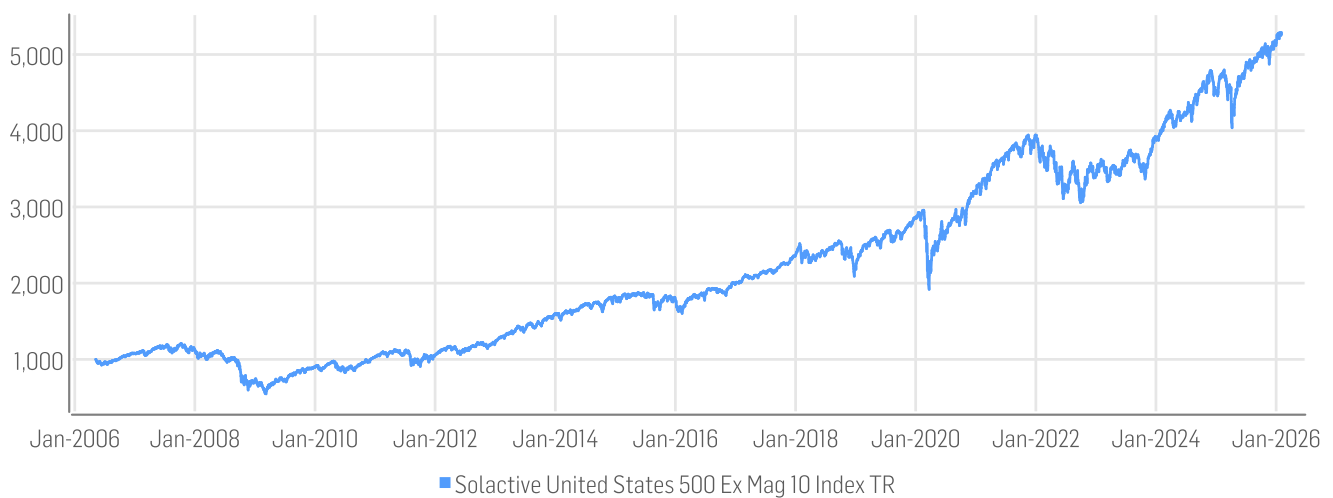

DESCRIPTION

The Solactive United States 500 Ex Mag 10 Index TR intends to track the performance of the largest 500 companies from the US stock market excluding 10 dominant companies and is based on the Solactive Global Benchmark Series. Constituents are weighted by free-float market capitalization. The index is calculated as a total return index in USD and reconstituted quarterly.

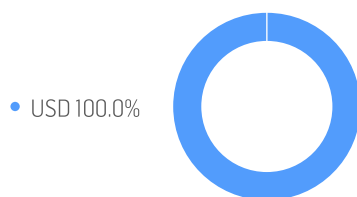

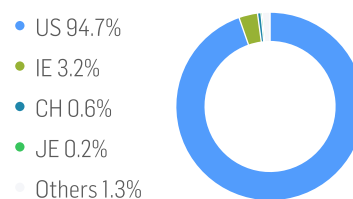
