DESCRIPTION

The Solactive Eurozone 50 Equal Weight Index-NTR tracks the performance of the 50 largest companies in the Eurozone in terms of free float market capitalization. The index composition is reviewed on a quarterly basis. The components of the index are equally weighted. The Index is a Net Total Return index minus a 5% decrement per annum.
