## F.A.Z. Euro Industrie Index (TR)

### DESCRIPTION

The F.A.Z. Euro Industrie Index includes companies whose primary business activity is in the industrial sector and which are domiciled and traded at an exchange in the Eurozone. From each Eurozone country the largest company from the industrial sector is included and subsequently further companies added up to a maximum of 25 components. The index members are weighted equally. The F.A.Z. Euro Industrie Index is calculated as a total return index in EUR and adjusted annually.

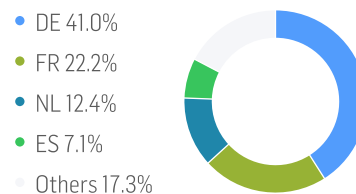
