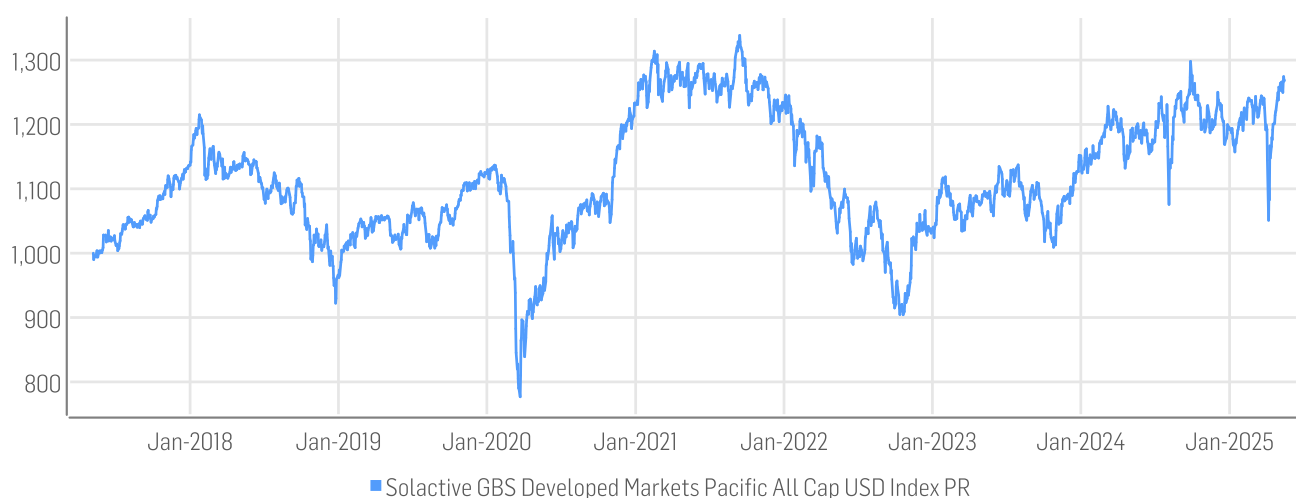

DESCRIPTION

The index intends to track the performance of the all cap covering approximately the largest 100% of the free-float market capitalization in the developed Pacific market. It is calculated as a price return index in USD and weighted by free-float market capitalization.

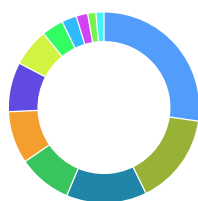

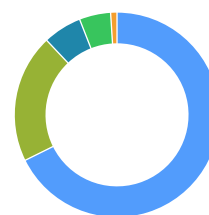
