It is calculated as a net total return index in EUR and weighted by free-float market capitalization.

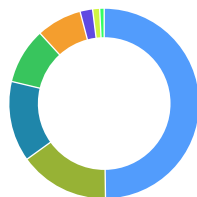

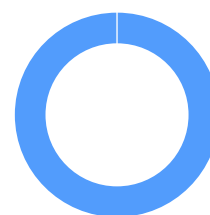
