


FACTSHEET - AS OF 14-May-2025 Solactive Value Investoren Index

The Solactive Value Investoren Index tracks the price movements in shares of investment companies whose investment strategy is value orientated. A maximum of 25 components are included and weighted according to market capitalization. The index is calculated as a total return index in EUR and adjusted annually.
