


FACTSHEET - AS OF 08-May-2025 Goldman Sachs Finance Reimagined Index

DESCRIPTION

The Goldman Sachs Finance Reimagined Index (the "Index") is designed to deliver exposure to companies with common equity securities listed on exchanges in certain developed markets that may benefit from the on-going structural changes in the support and delivery of financial services (the "Finance Reimagined Theme"). These structural changes include the impact of rapid technological change on the industry, including the effects of the development of blockchain technology, and the split in the asset management industry toward very low and high cost investment strategies.




